

Minutes of the Long Sutton Parish Council Meeting 5th July 2022

Held in the Committee Room, Long Sutton Village Hall at 7:30pm

The Public Session opened at 7:30pm.

Members of the public (MOP) in attendance who wished to comment on any of the planning applications to be discussed this evening were invited to comment during that agenda item. The meeting would be suspended in order for them to do so.

Matters raised: A MOP queried why no further progress had been made with the Long Sutton Green Charter, and that the charter was not available on the website. The new website is not live yet, and the charter will feature when the website is finalised. The PC environment champion will make contact with the MOP.

1 To receive apologies for absence (LGA 1972 S85 (1))

Apologies were received from Cllr Rousell and Cllr Stoddart-Stones. It was resolved to receive and approve the apologies submitted.

3 Minutes of the meeting 7th June 2022 and any matters arising.

4 County Councillors report

Both Cllr Kerley and Ruddle spoke briefly. Aside from training new councillors, the focus has been the budget.

5 <u>District Councillors Report</u>

Cllr Tucker gave a short verbal report. Area North met briefly. SSDC has an Investment Strategy of £145m giving a return of 6.9% gross.

Planning remains a cause for concern, with phosphate mitigation, and also shortage of staff. LSPC planning applications outstanding for more than 12 months are to be sent to Cllr Tucker to highlight to planning, as are the PC comments missing from the planning portal.

6 Parish Council Standing Orders

The Standing Orders, previously circulated, were discussed. There had been a few amendments to the model standing orders from National Association of Local Councils (NALC). The NALC model standing orders were adapted in line with Long Sutton Parish Council. It was resolved to adopt the standing ordered previously circulated.

7 Co-Option onto the Parish Council

A member of the parish, not present at the meeting, had expressed an interest at being co-opted onto the parish council. It was agreed to co-opt the member of the parish, but a point of order was raised regarding the vote. In order to clarify the point of order outside of the meeting, it was agreed to invite the member of the parish to the next meeting in September, and to consider the co-option at that time.
